Important notice:

With the objective to streamline the material supply chain, Philip Morris International Management SA has enabled an internet based system to manage materials quality activities with its suppliers.

Access to this system named SCP (Supplier Collaboration Portal) has been provided to PMI Suppliers. Access will be extended to our Suppliers Sub-Suppliers, provided that all confidentiality agreements in place with PMI Suppliers are respected and the Sub-suppliers have corresponding confidentiality obligations with your company.

^{*} Supplier Collaboration Portal (SCP) and Product Lifecycle Management (PLM).

Additional to above, suppliers are obliged to protect the confidentiality and integrity of PMI data. Only authorized personnel must be allowed to access PMI data. Access is individual and restricted to the named user, logging with someone else's user name is prohibited. Computers accessing PMI data must not be left unattended at any time and must be locked or shut down if unattended.

Passwords are personal and must not be exchanged between users. The PMI network password will need to be changed every 90 days and must have the following structure: minimum 8 digits must be a combination of figures, capital and small letters, and/or special characters.

Sub-Suppliers will be part of the PMI Supplier user group and will have access exclusively to the items which are granted access to this Supplier (SCP Supplier Access Control function). The access is restricted to download the necessary files and to upload modified files if required by PMI. The system records every performed action, such as viewing, downloading or uploading.

In order to allow a business partner to access the PMI SCP data base, the individual access must be requested by a PMI employee. Access to Sub-Suppliers will be given upon request from PMI Suppliers to the appointed members of the Sub-Supplier organization, limited to two per company.

Philip Morris International recognizes the value of the relationship with its Suppliers, nevertheless it is a must that provided data is treated as confidential and handled properly. It will as well be responsibility of the PMI Supplier and Sub-Supplier to make sure that PMI will be informed of any modification in their organizations prior to effect, to allow PMI to revoke the personal access.
